The statements filed in the report filed 22 days prior to the election shall include a list of each contribution received by the candidate, all in-kind contributions, the name and address of each donor, an aggregate total of all contributions and in-kind contributions received by the candidate, a list of each expenditure of campaign contributions made during the campaign period, and the recipient of each expenditure.
