<b>Meets</b>	<b>Classification of Audit Finding:</b> Auditors classify audit findings, by order of severity, as compliance, significant deficiency or material weakness.
<b>Does Not Meet</b>	<b>Exceptions from Site Visit:</b> Cited exceptions for most recent annual site visit.
