Bid security in the amount of five percent (5%) of the bid must accompany each bid in accordance with the Instructions to Bidders.

The Bidder's attention is directed to the requirements of the Contract Documents for adherence to applicable federal, state and local statutes, regulations and ordinances, payment of minimum wages and payment of taxes.

The Owner reserves the right to waive irregularities and to reject any or all bids as may be in the best interest of the school district. No bidder may withdraw his/her bid for 45 days after the actual date of the bid opening.
