1. Vendor's Contract Reference Number, *required to get contract pricing*
2. Albuquerque Public Schools Contract: Bid 17-027MG-AM Athletic and PE Equipment & Related Goods
3. Vendor's APS Price Agreement (PA) number (see vendor list below)
4. APS Site's "**Ship To**" address (*your location*)
5. List of items to be quoted
6. Your APS contact information, in case the vendor has a question regarding your request
7. Instruct the vendor to send you the quote via email in PDF format
