**Information for Vendor, when requesting a quote:**

*When requesting a quote, provide the following information to the vendor:*

1. Vendor's Contract Reference Number, *required to get contract pricing*
2. Albuquerque Public Schools Contract: Bid 18-056MG Medical Equipment & Supplies
3. Vendor's APS Price Agreement (PA) number (see vendor list below)
4. APS Site's **"Ship To"** address (*your location*)
5. List of items to be quoted
6. Your APS contact information, in case the vendor has a question regarding your request
7. Instruct the vendor to send you the quote via email in PDF format

**Header Comments (copy and paste into requisition):**

*You need to enter the following information on the requisition in the "Comments to Print on Purchase Orders" section of the Header. You may copy and paste this onto the requisition. Enter the applicable requisition number, PA number, quote number, quote date, and vendor contact name, phone and/or email information.*
